QUALIFYING REQUIREMENT

- 1. Construction of slope drain & dowel wall over MGR embankment and construction of labour shed for CHP at NSPCL, Expansion Power Plant.
- 1. The average annual turnover of the Bidder in the preceding three financial years as on the date of Techno-commercial bid opening **shall not be less than Rs. 39.35 Lakhs.**
- 2. The bidder should have experience of successfully completing the **similar works** within preceding 07 (seven) years reckoned as on the date of techno commercial bid opening, should be either of the following: -
 - Three similar completed works costing not less than the amount equal to **Rs. 31.48 Lakhs each** (inclusive of taxes)

• Two similar completed works costing not less than the amount equal to **Rs. 39.35 Lakhs each** (inclusive of taxes).

OR

 One similar completed works costing not less than the amount equal to Rs. 62.96 Lakhs (inclusive of taxes).

Note:

- ♦ Similar works means: The completed works comprising of construction job which includes RCC works or steel structure works.
- ◆ **Completed means:** The executed/ completed portion of BOQ, even if the work has not been completed in totality (subject to furnishing of documentary proof of executed value of the work).
- While computing the annual turnover other income shall not be considered.
- ◆ In case where audited results for the last preceding financial year as on the date of Techno-Commercial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the Certificate from practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the parameters. Further, a Certificate would be required CEO/CFO/Proprietor/Partners as per the format enclosed in the bidding documents stating that the financial results of the Company are under audit as on the date of Techno-Commercial bid opening and the Certificate from the practicing Chartered Accountant certifying the financial parameters is not available.

NIT Conditions

- Bid documents will be issued to all the parties on their request (cost of tender document to be made by a crossed demand draft / pay order / banker's cheque in favour of NTPC SAIL POWER COMPANY LIMITED payable at Bhilai) for issue of bid documents without prima-facie examination of their qualification status. However, issue of bid documents shall not mean that bidders are considered qualified. Tender document fee will not be refunded. Request for tender documents received after the last date as mentioned above due to delays postal/courier services shall not be entertained.
- 2. Complete set of bidding documents are also available on NTPC website www.ntpctender.com prospective bidders can down load the same for submission of bids after tendering the cost of bidding documents directly on the website.
- 3. NSPCL reserves the right to reject any or all bids or cancel / withdraw the Invitation for bids without assigning any reason whatsoever and in such case no bidder / intending bidder shall have any claim arising out of such action.
- 4. Agencies are advised to visit the site to familiarize themselves with the nature of work and the site conditions.
- 5. Small-scale industries registered with NSIC/MSME shall be exempted for payment of EMD & Tender Fee.
