Instruction for e-bidding:

- 1. The bidder must have Digital Signature Certificate (Class-III).
- **2.** The bidders who already have valid SRM User ID:
- a) Login the SRM Portal and click on RFx and Auction button.
- b) Rfx will be available to view for all the bidders which are already having valid SRM User ID's.
- c) Interested bidders have to register first against the Bid invitation by clicking on "Register" button placed into Rfx header segment.
- d) Tender document fee should be submitted on line/offline (Demand Draft / Pay Order / Banker's Cheque only except exemption document and EMD also may be submitted online/offline.
- e) Once Registration step & Tender fee submission is done by bidder and the tender fee received by the NSPCL and updated into the system then Bidder could be able to "Create Response" and submit the bids against the Bid invitation into the system.
- 3. New Bidders which are not having SAP/ERP Vendor Code and or SRM User ID:
- a) In case a new bidder wants to participate for a particular Bid invitation in SRM portal, the bidder first of all has to submit the filled Registration Form & NEFT Form along with required supporting documents e.g. as specified in forms, till 31/05/2022 to C&M department, NSPCL Bhilai in hard copy or scanned copy through e-mail at: rashmikumari@nspcl.co.in
- b) C&M department will initiate the process for vendor ID creation in SAP & send the bidders SRM Credentials (User ID along with initial Password)
- c) After creation of SRM Credentials the step 2 (above) shall be followed by the bidder.

QUALIFYING REQUIREMENT

Name of Work: "Job Contract For Operation Assistance For Main Plant and Offsite Area/DM Plant of PP-II 1x250 MW Expansion Project, NSPCL Rourkela".

1.1 Financial Requirement:

1.1.1

The bidder should have executed similar works OPERATION ASSITANCE FOR MAIN PLANT AND OFFSITE AREA/DM Plant in a thermal power plant having duration of one year or more during last 07 years of scheduled technical bid opening date which fulfils either of the following criteria as follow:

1.1.2

(i) 01 (One) similar completed works costing not less than the amount equal to Rs.97.08Lakhs

OR

(ii) 02 (Two) similar completed works costing not less than the amount equal to **Rs.60.67Lakhs** each.

OR

(iii) 03 (Three) similar completed works costing not less than the amount equal to **Rs.48.54 Lakhs** each.

1.1.3

The average turnover of the bidder in the preceding three (03) financial years as on the date of Techno-Commercial bid opening shall not be less than **Rs.121.35** Lakhs.

Note:-

- I. The phrase "Similar Works" means: "Assistance in Main Plant/Offsite/DM Plant Operation in a thermal power plant."
- II. "Executed" means "The executed /completed that portion of BOQ of Work Order (subject to furnishing proof of executed value of the work in the form of copies of RA Bills, Relevant PO copy and client's completion certificate/RA bill/Final Deviation Statement).
- III. The bidder shall submit the Audited Balance Sheet and Profit & Loss Account for the specified period. In case where Audited results for the preceding FY are not available, certificate of financial statements from a practicing Chartered Accountant shall also be considered acceptable. In case, Bidder is not able to submit the Certificate from practicing Chartered Account certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a certificate would be required from CEO/CFO as per the format enclosed in the bidding documents stating that the financial results of the company are under audit as on the date of Techno-commercial bid opening and the certificate from the practicing Chartered Accountant certifying the financial parameters is not available.
- IV. Other income shall not be considered for arriving annual turnover.
- V. All the values mentioned in the Clause 1.1.2 are inclusive of taxes and duties.

NIT Conditions

- 1. Bid documents will be issued to all the parties on their request (cost of tender document to be made by a crossed demand draft / pay order / banker's cheque in favour of NTPC SAIL POWER COMPANY LIMITED payable at Bhilai) for issue of bid documents without prima-facie examination of their qualification status. However, issue of bid documents shall not mean that bidders are considered qualified. Tender document fee will not be refunded. Request for tender documents received after the last date as mentioned above due to delays postal/courier services shall not be entertained.
- 2. NSPCL reserves the right to reject any or all bids or cancel / withdraw the Invitation for bids without assigning any reason whatsoever and in such case no bidder / intending bidder shall have any claim arising out of such action.
- 3. Agencies are advised to visit the site to familiarize themselves with the nature of work and the site conditions.
- 4. If the last date of receiving application and date of bid opening coincide with a holiday, the date will be shifted to the next working day.
- 5. Micro and Small Enterprises (MSEs) registered with Udyam as specified by Ministry of Micro, Small and Medium Enterprises as per MSMED Act 2006, for goods produced and services rendered, shall be issued the bid documents free of cost and shall be exempted from paying Earnest Money Deposit & shall be issued the bidding documents free of cost and shall be exempted from payment of Tender Fee.
