#### **Instruction for e-bidding:**

1. The bidder must have Digital Signature Certificate (Class-III).

- 2. The bidders who already have valid SRM User ID:
  - a) Login the SRM Portal and click on RFx and Auction button.
  - b) Rfx will be available to view for all the bidders which are already having valid SRM User ID's.
  - c) Interested bidders have to register first against the Bid invitation by clicking on "Register" button placed into Rfx header segment.
  - d) Once Registration step & Tender fee submission is done by bidder and the tender fee received by the NSPCL and updated into the system then Bidder could be able to "Create Response" and submit the bids against the Bid invitation into the system.

3. New Bidders who are not having SAP/ERP Vendor Code and / or SRM User ID:

- a) In case a new bidder wants to participate for a particular Bid invitation in SRM portal, the bidder first of all has to submit the filled Registration Form & EFT Form along with required supporting documents e.g. as specified in forms, till 26/06/2023 to C&M department, NSPCL Bhilai in hard copy or scanned copy through e-mail at rnshukla@nspcl.co.in or ushakumai@nspcl.co.in or rashmikumari@nspcl.co.in.
- b) C&M department will initiate the process for vendor ID creation in SAP & send the bidder's SRM Credentials (User ID along with initial Password) to them.
