- 2. The bidders who already have valid SRM User ID:
 - a) Login the SRM Portal and click on RFx and Auction button.
 - b) Rfx will be available to view for all the bidders which are already having valid SRM User ID's.
 - c) Interested bidders have to register first against the Bid invitation by clicking on "Register" button placed into Rfx header segment.
 - d) Once Registration step & Tender fee submission is done by bidder and the tender fee received by the NSPCL and updated into the system then Bidder could be able to "Create Response" and submit the bids against the Bid invitation into the system.
- 3. New Bidders who are not having SAP/ERP Vendor Code and / or SRM User ID:

1.1.3	The average annual turnover of the Bidder, in the preceding three (03) financial years as on				
	the date of Technical bid opening should not be less than Rs. 49.99 Lakhs

	1. The bidder shall possess valid special class/First Class boiler repairer license issued				
	by Directorate of Factories & Boilers, Govt. of Odisha.

	certificate of financial statements from a practicing Chartered Accountant shall also be				
	considered acceptable. In case, Bidder is not able to submit the Certificate from				
	practicing Chartered Account certifying its financial parameters, the audited results of				
	three consecutive financial years preceding the last financial year shall be considered for				
	evaluating the financial parameters. Further, a certificate would be required from				

CEO/CFO as per the format enclosed in the bidding documents stating that the financial results of the company are under audit as on the date of Techno-commercial bid opening and the certificate from the practicing Chartered Accountant certifying the financial parameters is not available.

IV) Other income shall not be considered for arriving at annual turnover.

V) All the values mentioned in the clause 1.1.2. are inclusive of taxes and duties.
