#### **Instruction for e-bidding:**

- 1. The bidder must have Digital Signature Certificate (Class-III).
- 2. The bidders who already have valid SRM User ID:
- a) Login the SRM Portal and click on RFx and Auction button.
- b) Rfx will be available to view for all the bidders which are already having valid SRM User ID's.
- c) Interested bidders have to register first against the Bid invitation by clicking on "Register" button placed into Rfx header segment.
- d) Tender document fee should be submitted on line/offline (Demand Draft / Pay Order / Banker's Cheque only except exemption document and EMD also may be submitted online/offline.
- e) Once Registration step & Tender fee submission is done by bidder and the tender fee received by the NSPCL and updated into the system then Bidder could be able to "Create Response" and submit the bids against the Bid invitation into the system.
- 3. New Bidders which are not having SAP/ERP Vendor Code and or SRM User ID:
- a) In case a new bidder wants to participate for a particular Bid invitation in SRM portal, the bidder first of all has to submit the filled Registration Form & NEFT Form along with required supporting documents e.g. as specified in forms, till 16/10/2021 to C&M department, NSPCL Bhilai in hard copy or scanned copy through e-mail at: rashmikumari@nspcl.co.in
- b) C&M department will initiate the process for vendor ID creation in SAP & send the bidders SRM Credentials (User ID along with initial Password)
- c) After creation of SRM Credentials the step 2 (above) shall be followed by the bidder.

# **QUALIFYING REQUIREMENT**

- 1. Deployment of Hired Vehicles at Various Departments for 08 Hrs. & 24 Hrs. duty at NSPCL-Bhilai.
- 1. The agency should have valid PF and ESI code.
- 2. The agency should have experience of deployment of at least one vehicle for a minimum period of 1 year in any of the PSU or its Joint Venture Company/Govt. or Semi Govt. Department/SEB/Public Ltd Company/Private Ltd company during the last 07 years as on the date of **Technical bid opening**.
- 3. **Case-I:** If the bidder has quoted for Package-I only (8 Nos. of vehicles on 8 Hour duty). The average annual turnover of the bidder in the preceding 03 (three) financial years as on the date of Technical bid **opening shall not be less than Rs.59.86 lakhs.**
- 4. **Case-II:** If the bidder has quoted for Package-II only (8 Nos. of vehicles on 24 Hour duty). The average annual turnover of the bidder in the preceding 03 (three) financial years as on the date of Technical bid **opening shall not be less than Rs.86.32 lakhs.**
- 5. **Case-III:** If the bidder has quoted for both Package-I and Package-II (8 Nos. of vehicles on 8 Hour duty as well as 8 Nos. of vehicles 24 Hour duty). The average annual turnover of the bidder in the preceding 03 (three) financial years as on the date of **Technical bid opening shall not be less than Rs. 146.175 lakhs.**

#### Note:

- While computing the annual turnover other income shall not be considered.
- > In case where audited results for the last preceding financial year as on the date of Techno-Commercial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the certificate from practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial Further, certificate would required parameters. а be CEO/CFO/Proprietor/partners as per the format enclosed in the bidding documents stating that the financial results of the company are under audit as on the date of Techno-Commercial bid opening and certificate from the practicing chartered accountant certifying the financial parameters is not available.

#### Remarks: -

The average turnover requirement has been arrived taking into consideration the estimate value of respective Packages (i.e. Package I: 8 Nos. of vehicles on 8 Hour duty, Package-II: 8 Nos. of vehicles on 24 Hour duty & Cumulative value considering both the packages I & II).

# **NIT Conditions**

- 1. Bid documents will be issued to all the parties on their request (cost of tender document to be made by a crossed demand draft / pay order / banker's cheque in favour of NTPC SAIL POWER COMPANY LIMITED payable at Bhilai) for issue of bid documents without prima-facie examination of their qualification status. However, issue of bid documents shall not mean that bidders are considered qualified. Tender document fee will not be refunded. Request for tender documents received after the last date as mentioned above due to delays postal/courier services shall not be entertained.
- 2. NSPCL reserves the right to reject any or all bids or cancel / withdraw the Invitation for bids without assigning any reason whatsoever and in such case no bidder / intending bidder shall have any claim arising out of such action.
- 3. Agencies are advised to visit the site to familiarize themselves with the nature of work and the site conditions.
- 4. Bidder has to submit the Bid Security Declaration Form in lieu of EMD.

  NOTE: Bidder may note that in case they do not submit the aforesaid declaration or no Confirmation is indicated by them or statement/any declaration like 'later', 'to be Furnished later', 'NA' etc. are indicated against the declaration, then the bid shall be Rejected by EMPLOYER as being non-responsive and shall not be opened.
- 5. If the last date of receiving application and date of bid opening coincide with a holiday, the date will be shifted to the next working day.
- 6. Micro and Small Enterprises (MSEs) registered with District Industries Centres or Khadi and Village Industries Commission or Khadi and Village Industries Board or Coir Board or National Small Industries Corporation or Directorate of Handicrafts and Handloom/Udyam registered or any other body specified by Ministry of Micro, Small and Medium Enterprises as per MSMED Act 2006, for goods produced and services rendered, shall be issued the bidding documents free of cost and shall be exempted from payment of Tender Fee. (Subject to submission of copy of registration giving details, such as validity, monetary limit, etc.).
