**Instruction for e-bidding:**

1. The bidder must have Digital Signature Certificate (Class-III).
2. The bidders who already have valid SRM User ID:
  - a) Login the SRM Portal and click on RFx and Auction button.
  - b) Rfx will be available to view for all the bidders which are already having valid SRM User ID's.
  - c) Interested bidders have to register first against the Bid invitation by clicking on “Register” button placed into Rfx header segment.
  - d) Once Registration step & Tender fee submission is done by bidder and the tender fee received by the NSPCL and updated into the system then Bidder could be able to “Create Response” and submit the bids against the Bid invitation into the system.
3. New Bidders who are not having SAP/ERP Vendor Code and / or SRM User ID:

<b>1.1</b>	<p>The bidder should have executed the work of “<b>Civil works involving earth/ ash work in ash dyke/dam/ embankment/ reservoir/ canal/ pond/ building/ road/ construction or maintenance work</b>” in any of the following manner-</p> <p style="padding-left: 40px;">a) One (1) order of value not less than <b>₹ 82.27 Lakh</b></p> <p style="text-align: center;">OR</p> <p style="padding-left: 40px;">b) Two (2) orders of value not less than <b>₹ 51.42 Lakh</b> each</p> <p style="text-align: center;">OR</p> <p style="padding-left: 40px;">c) Three (3) orders of value not less than <b>₹ 41.14 Lakh</b> each</p>
<b>2.0</b>	<b>Financial Requirement -</b>
<b>2.1</b>	<p>The Average Annual Turnover of the Bidder, should not be less than <b>₹ 102.84 Lakhs</b> (Rupees One Crore Two lakhs Eighty Four Thousand only) during the preceding three (03) financial years as on date of technical bid opening.</p>
<b><u>Notes</u></b>	<p>(I) The word “<b>Executed</b>” means the bidder should have achieved the criterion specified in Qualifying requirements even if the total contract is not completed/ closed. A work executed in the preceding seven (7) years reckoned as on the date of technical bid opening, even if it has been started earlier, will also be considered for meeting the requirement against clause 1.1 above. Agency has to furnish proof of executed value of the work in the form of copies of RA Bills, relevant PO copy and client’s completion certificate/ Final deviation statement etc in support of meeting the Qualifying requirement.</p> <p>(II) Values as per Clause 1.1 and 2.1 shall be considered inclusive of taxes &amp; duties.</p> <p>(III) While computing the annual turnover other income shall not be considered.</p> <p>(IV) In case where audited results for the last preceding financial year as on the date of Techno commercial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the Certificate from a practicing Chartered Account certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a certificate would be required from the CEO/CFO/ Proprietor/Partners as per the format enclosed in the bidding documents stating that the financial result of the company are under audit as on the date of Technical bid opening and the certificate from the practicing Chartered Accountant certifying the financial parameters is not available.</p>

## **NIT Conditions**

1.
