#### **Instruction for e-bidding:**

- 1. The bidder must have Digital Signature Certificate (Class-III).
- 2. The bidders who already have valid SRM User ID:
- a) Login the SRM Portal and click on RFx and Auction button.
- b) Rfx will be available to view for all the bidders which are already having valid SRM User ID's.
- c) Interested bidders have to register first against the Bid invitation by clicking on "Register" button placed into Rfx header segment.
- d) Tender document fee should be submitted on line/offline (Demand Draft / Pay Order / Banker's Cheque only except exemption document and EMD also may be submitted online/offline.
- e) Once Registration step & Tender fee submission is done by bidder and the tender fee received by the NSPCL and updated into the system then Bidder could be able to "Create Response" and submit the bids against the Bid invitation into the system.
- 3. New Bidders which are not having SAP/ERP Vendor Code and or SRM User ID:
- a) In case a new bidder wants to participate for a particular Bid invitation in SRM portal, the bidder first of all has to submit the filled Registration Form & NEFT Form along with required supporting documents e.g. as specified in forms, till **26**//**11/2022** to C&M department, NSPCL Bhilai in hard copy or scanned copy through e-mail at: rashmikumari@nspcl.co.in
- b) C&M department will initiate the process for vendor ID creation in SAP & send the bidders SRM Credentials (User ID along with initial Password)
- c) After creation of SRM Credentials the step 2 (above) shall be followed by the bidder.

## **QUALIFYING REQUIREMENT**

Name of Work: "Biennial Maintenance Contract for HT-LT Motor maintenance of CPP-II & CPP-III, NSPCL-Durgapur".

#### 1. 0 FINANCIAL CRITERIA:

**1.1 Turnover:** The average annual turnover of the bidder in preceding three (03) financial years as on date of Technical bid opening shall not be less than **Rs.90.87 lakh** (Rupees Ninety lakh eighty seven thousand only).

#### 2.0 TECHNICAL CRITERIA:

- 2.1 The bidder should have (a) experience in Overhauling/ Maintenance/ Rewinding of HT motors OR (b) experience in overhauling/ Maintenance/ Rewinding of HT & LT motors ,for any industrial installation, as a Main contractor or as a sub- contractor of main contractor.
- 2.2 The bidder should have executed works mentioned under 2.1 above, in last seven years as on date of Technical Bid opening, having executed value not less than as under-
  - A. Single work order of value of Rs 72.70 lakhs in INR. (Inclusive of taxes & duties)

    OR
  - B. Two work orders of value of Rs 45.43 lakhs each in INR. (Inclusive of taxes & duties)

    OR
  - C. Three work orders of value of Rs 36.35 lakhs each in INR. (Inclusive of taxes & duties)

**Notes:**1. The word Executed means that the Bidder should have achieved the progress specified in the QR para 2.2 even if total contract /work order is not completed /closed. The same shall be supported by documentary evidence issued by the owner / employer such as completion certificate/ joint protocol / Running / Final Bills etc.

- 2. For Financial selection criteria, QR para 1.0 Bidder must submit copy of Audited Balance sheet and profit & loss Account for the specified period. In case, where audited results for the Last Financial year as on the Last date of submission of Application, are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case Bidder is not able to submit the certificate from the practicing chartered accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year, shall be considered for evaluating the financial parameters.
- 3. Other income shall not be considered for calculation of annual Turnover.
- 4. For QR No. 2.1 & 2.2, the bidder must submit the certificates from their customers as evidence for the same.
- 5. The above contract falls under the category of AMC/O&M contract of 02years or more duration, hence the values under cause no 2.2 has been accounted on annualized estimate..

# **NIT Conditions**

- 1. Bid documents will be issued to all the parties on their request (cost of tender document to be made by a crossed demand draft / pay order / banker's cheque in favour of NTPC SAIL POWER COMPANY LIMITED payable at Bhilai) for issue of bid documents without prima-facie examination of their qualification status. However, issue of bid documents shall not mean that bidders are considered qualified. Tender document fee will not be refunded. Request for tender documents received after the last date as mentioned above due to delays postal/courier services shall not be entertained.
- 2. NSPCL reserves the right to reject any or all bids or cancel / withdraw the Invitation for bids without assigning any reason whatsoever and in such case no bidder / intending bidder shall have any claim arising out of such action.
- 3. Agencies are advised to visit the site to familiarize themselves with the nature of work and the site conditions.
- 4. If the last date of receiving application and date of bid opening coincide with a holiday, the date will be shifted to the next working day.
- 5. The subject work being works contracts, benefits under public procurement policy for MSEs shall not be extended against this tender.
