#### **Instruction for e-bidding:**

- 1. The bidder must have Digital Signature Certificate (Class-III).
- 2. The bidders who already have valid SRM User ID:
- a) Login the SRM Portal and click on RFx and Auction button.
- b) Rfx will be available to view for all the bidders which are already having valid SRM User ID's.
- c) Interested bidders have to register first against the Bid invitation by clicking on "Register" button placed into Rfx header segment.
- d) Tender document fee should be submitted on line/offline (Demand Draft / Pay Order / Banker's Cheque only except exemption document and EMD also may be submitted online/offline.
- e) Once Registration step & Tender fee submission is done by bidder and the tender fee received by the NSPCL and updated into the system then Bidder could be able to "Create Response" and submit the bids against the Bid invitation into the system.
- 3. New Bidders which are not having SAP/ERP Vendor Code and or SRM User ID:
- a) In case a new bidder wants to participate for a particular Bid invitation in SRM portal, the bidder first of all has to submit the filled Registration Form & NEFT Form along with required supporting documents e.g. as specified in forms, till 22/03/2023 to C&M department, NSPCL Bhilai in hard copy or scanned copy through e-mail at: rashmikumari@nspcl.co.in
- b) C&M department will initiate the process for vendor ID creation in SAP & send the bidders SRM Credentials (User ID along with initial Password)
- c) After creation of SRM Credentials the step 2 (above) shall be followed by the bidder.

## **QUALIFYING REQUIREMENT**

Name of Work: "Sinking of Borewell and installation of electric pump in Different schools of Nuagaon and Bisra Blocks of Sundergarh Distt.".

#### 1. Financial Criteria:

**1.1** The Bidder should have executed civil works including water supply systems and or other miscellaneous civil jobs of similar nature within preceding 07 years reckoned as on the date of Techno-commercial bid opening

### 1.2

- (i) 01(One)similar completed works costing not less than the amount equal to  $\bf Rs~116.60~Lakhs$   $\bf OR$
- (ii) 02(Two) similar completed works costing not less than the amount equal to **Rs 72.88 Lakhs** each.

OR

- (iii) 03(Three) similar completed works costing not less than the amount equal to **Rs 58.30 Lakhs each**.
- **1.3** The average turnover of the bidder in the preceding three (3) financial years as on the date of Techno-commercial bid opening shall not be less than **Rs. 145.76 Lakhs.**

## **Notes:**

- I. The work "Executed" means that the bidder should have achieved the progress specified in the QR, even if total contract / work order is not completed / closed. The same shall be supported by documentary evidence issued by the owner/ employer such as completion certificate/ Joint protocol / running/ final bill etc.
- II. Similar **nature** means the agency must have experience of executing any civil works involving concrete work (RCC/PCC)/ Brick work/ Plaster work/ Tiles work / Tube well boring works/ water supply works.
- III. The bidder shall submit the Audited Balance Sheet and Profit & Loss account for the specified period. In case, where audited results for the preceding FY are not available, certificate of financial statements from a practicing Chartered Accountant shall also be considered acceptable. In case, Bidder is not able to submit the Certificate from practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year, shall be considered for evaluating the financial parameters. Further, a Certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that the financial results of the Company are under audit as on the date of Techno-commercial bid opening and the Certificate from the practising Chartered Accountant certifying the financial parameters is not available.
- IV. Other income shall not be considered for arriving Annual turnover.
- V. All the values mentioned in the Clause 1.2 are inclusive of taxes and duties.

## **NIT Conditions**

- 1. Bid documents will be issued to all the parties on their request (cost of tender document to be made by a crossed demand draft / pay order / banker's cheque in favour of NTPC SAIL POWER COMPANY LIMITED payable at Bhilai) for issue of bid documents without prima-facie examination of their qualification status. However, issue of bid documents shall not mean that bidders are considered qualified. Tender document fee will not be refunded. Request for tender documents received after the last date as mentioned above due to delays postal/courier services shall not be entertained.
- 2. NSPCL reserves the right to reject any or all bids or cancel / withdraw the Invitation for bids without assigning any reason whatsoever and in such case no bidder / intending bidder shall have any claim arising out of such action.
- 3. Agencies are advised to visit the site to familiarize themselves with the nature of work and the site conditions.
- 4. If the last date of receiving application and date of bid opening coincide with a holiday, the date will be shifted to the next working day.
- 5. The subject work being works contracts, benefits under public procurement policy for MSEs shall not be extended against this tender.
