Clause 4(b) is modified as follows:

Agency has also to submit a Certificate of receipt for Pond Ash utilized in National Highway (NH) from M/s APCO Infratech Pvt. Ltd., who are executing the job of NH-2 construction in Asansol area. This certificate should mention quantity in Metric Ton (MT) vis-a-vis the distance of utilization (in Kilometer) from NSPCL Ash Dyke. One (1) cubic meter of Pond Ash will generally weigh in the range of 01.1 MT to 01.4 MT.

4(c) Modified Terms is as follows:

The above two certificates shall be used for progressive payment to the agency. Payment will be made based on the volume as per cl. 4(a) and the distance as per cl. 4(b).
