Qualifying Requirement

The Bidder should meet Qualifying Requirements (QR) stipulated hereunder along with notes

- 1.0 Average Annual Turnover of the bidder in the preceding three (3) financial years as on date of bid opening shall not be less than **Rs. 355.5 Lakh**.
- 2.0
 - a) The bidder should have designed, manufactured & supplied at least two (2) numbers (one each at two different installations) of 33 KV or above class oil filled reactor of at least 5.332 MVAr capacity / transformers of at least 40MVA capacity, which should have been in successful operation for at least two years as on the date of Techno-Commercial bid opening.
AND
 - b) The bidder should have its own facilities for conducting all routine and type tests as per IS:5553 (Part-3) / IS:2026 (except short circuit test).
AND
 - c) 5.332 MVAr, 33 KV or higher rated oil filled reactor / 40MVA, 33 kV or higher rated oil filled transformer manufactured by Bidder should have been successfully short circuit tested.
- 3.0 The bidder must have experience of having successfully completed in the last 7 (seven) years from the date of bid opening as per the following.
 - a. One similar work of value not less than **Rs. 142.2 Lakh**
OR
 - b. Two similar works of value not less than **Rs. 88.88 Lakh each**
OR
 - c. Three similar works of value not less than **Rs. 71.1 Lakh each**

Notes:

- i) The word "Similar Work" means designing, manufacturing & supplying of oil filled reactors / transformers of at least 33 KV voltage class.
- ii) In case the Bidder is not able to furnish its audited financial statements on standalone entity basis, the un-audited unconsolidated financial statements of the Bidder can be considered acceptable provided the Bidder furnishes the following further documents for substantiation of its qualification.
 - a. Copies of the un-audited unconsolidated financial statements of the Bidder along with copies of the audited consolidated financial statements of the Holding Company.
 - b. A Certificate from the CEO / CFO of the Holding Company, as per the format enclosed in the bid documents, stating that the un-audited unconsolidated financial statements form part of the Consolidated Annual Report of the company.In case where audited results for the last preceding financial year are not available, certification of financial statements from a practicing Chartered Accountant shall also be considered acceptable.
- iii) For QR no 2.0, the bidder must submit certificate of successful operation for at least two years
- iv) Necessary documentary evidence in support of the above criteria of QR to be furnished by the bidder.
