#### Instruction for e-bidding:

- **1.** The bidder must have Digital Signature Certificate (Class-III).
- 2. The bidders who already have valid SRM User ID:
  - a) Login the SRM Portal and click on RFx and Auction button.
  - b) Rfx will be available to view for all the bidders which are already having valid SRM User ID's.
  - c) Interested bidders have to register first against the Bid invitation by clicking on "Register" button placed into Rfx header segment.
  - d) Once Registration step & Tender fee submission is done by bidder and the tender fee received by the NSPCL and updated into the system then Bidder could be able to "Create Response" and submit the bids against the Bid invitation into the system.
- **3.** New Bidders who are not having SAP/ERP Vendor Code and / or SRM User ID:
  - a) In case a new bidder wants to participate for a particular Bid invitation in SRM portal, the bidder first of all has to submit the filled Registration Form & EFT Form along with required supporting documents e.g. as specified in forms, till 01/09/2023 (12.00 Hrs.) to C&M department, NSPCL Bhilai in hard copy or scanned copy through e-mail at <a href="mailto:nbanerjee@nspcl.co.in">nbanerjee@nspcl.co.in</a> or <a href="mailto:rnshukla@nspcl.co.in">rnshukla@nspcl.co.in</a> or </a>

2.2	The Net worth requirement to be specified as not being less than 100% of the Bidder's paid up share capital as on the last day of the preceding financial year. In case the Bidder meets the requirement of Net worth based on the strength of its Subsidiary(ies) and/or Holding Company and/or Subsidiaries of the Holding Companies wherever applicable, the Net worth of the Bidders and its Subsidiary(ies) and/or Holding Company, and/or Subsidiary(ies) of the Holding Company, in combined manner should not be less than100% of their total paid up share capital. However, individually, their Net worth should not be less than 75% of respective paid up share capitals. - 4. If the last date of receiving application and date of bid opening coincide with a holiday, the date will be shifted to the next working day.
