- 1. The bidder must have Digital Signature Certificate (Class-III).
- 2. The bidders who already have valid SRM User ID:
- a) Login the SRM Portal and click on RFx and Auction button.
- b) Rfx will be available to view for all the bidders which are already having valid SRM User ID's.
- c) Interested bidders have to register first against the Bid invitation by clicking on "Register" button placed into Rfx header segment.
- d) Once Registration step & Tender fee submission is done by bidder and the tender fee received by the NSPCL and updated into the system then Bidder could be able to "Create Response" and submit the bids against the Bid invitation into the system.
- 3. New Bidders who are not having SAP/ERP Vendor Code and / or SRM User ID:

## 1.0 QUALIFYING REQUIREMENTS

The Bidder should be OEM M/S FPM S. A Poland

The bidders who wish to participate in the bidding shall satisfactorily establish that they fulfill the following qualifying requirements (QR).

# 2.0 TECHNICAL CRITERIA:

- **2.1** The bidder should have successfully executed during preceding 7(seven) years from the date of bid opening, the supply of grinding rings for ball and race mills to any process industries as per the following:
  - A. Single supply order having value not less than Rs 327 Lakhs

#### **OR**

B. Two supply orders having value not less than Rs 204 Lakhs each

#### OR

- C. Three supply orders having value not less than Rs 164 Lakhs each
- **2.2** The bidder should be a manufacturer of MKM25J/33 J/E type coal pulverizes and should have supplied such coal pulverisers to any industry which is in successful operation for at least two years as on date of NIT publication with the same type of grinding elements of Hi- Chrome/Ni-Hard as offered by the bidder.

### OR

The bidder should be a manufacturer of Ni-hard/ Hi chrome grinding rings and should have supplied at least one (1) number of Ni-hard/ Hi chrome grinding ring for ball and race type mill to any process industry during last three years from the date of publication of NIT.

**2.3** Bidder should have either himself or through a company / agency in which he has controlling stake, own following manufacturing and testing facilities for use by the bidder for manufacturing of the grinding elements (bidder to furnish proof of ownership/controlling stake of the facilities along with they bid).

### 2.3.1 MANUFACTURING FACILITIES

- a) Casting and machining facility for manufacturing of Hi-chrome/ Ni hard grinding rings of Ball and Race type mill of minimum grinding ring diameter 3.0 meter having hardness of minimum 59 HRC/550 BHN
- b) Single piece casting facility of minimum 5 MT.
- c) Heat treatment facility of grinding rings and hollow balls.

### 2.3.2 TESTING FACILITIES

- a) Hardness testing
- b) Micro structure testing
- c) Chemical composition testing
- d) Ultrasonic testing machine
- e) Spectrometer/Spectrogram
- f) Outside micrometer

## NOTE:

- (i) For Clause No. 2.0 the bidder must submit documentary evidence in support of meeting the QR like copy of supply completion certificate from the client/ Purchase order along with stores Receipt Voucher (SRV) OR Invoice / protocol jointly signed by the purchaser and supplier. The word "executed" shall mean the order value mentioned in the QR for the supply completed even if the total purchase order (s) is not completed/closed.
- (ii) All values as mentioned in Clause 2.0 shall be inclusive of all taxes and duties

### 3.0 FINANCIAL CRITERIA:

3.1 Average annual turnover of the bidder in the preceding three (3) financial years from the date of bid opening shall not be less than Rs 408 Lakhs (Rupees Four Crores and Eight Lakhs only).

#### NOTE:

- For Clause 3.1, the bidder shall submit the audited balance sheets and profit & loss account for the specified period. In case where audited results for the last financial year as on the date of techno commercial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the certificate from practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a Certificate would be required from the CEO/CFO as per the format enclosed in the bidding document; stating that the Financial results of the Company are under audit as on the date of Techno commercial bid opening and the Certificate from the practicing Chartered Accountant certifying the financial parameters is not available.
- Other income shall not be considered for computing annual turnover.
- The figures indicated in 3.0 are inclusive of Taxes and Duties.

# **NIT Conditions**

- 1. Bid documents will be issued to all the parties on their request (cost of tender document to be made by a crossed demand draft / pay order / banker's cheque in favour of NTPC SAIL POWER COMPANY LIMITED payable at Bhilai) for issue of bid documents without prima-facie examination of their qualification status. However, issue of bid documents shall not mean that bidders are considered qualified. Tender document fee will not be refunded. Request for tender documents received after the last date as mentioned above due to delays postal/courier services shall not be entertained.
- 2. NSPCL reserves the right to reject any or all bids or cancel / withdraw the Invitation for bids without assigning any reason whatsoever and in such case no bidder / intending bidder shall have any claim arising out of such action.
- 3. Agencies are advised to visit the site to familiarize themselves with the nature of work and the site conditions.
- 4. If the last date of receiving application and date of bid opening coincide with a holiday, the date will be shifted to the next working day.
- 5. Micro and Small Enterprises (MSEs) registered with Udyam as specified by Ministry of Micro, Small and Medium Enterprises as per MSMED Act 2006, for goods produced and services rendered, shall be issued the bid documents free of cost and shall be exempted from paying Earnest Money Deposit & shall be issued

the bidding documents free of cost and shall be exempted from payment of Tender Fee.
