## QUALIFYING REQUIREMENT

### **1. Monitoring and management of water quality, O&M of WCTP and other services at Power Plant-II, Bhilai.**

1. The Bidder should have executed work of
  - a) Operation of water treatment plant for DM water production capacity at least 50 m<sup>3</sup>/ hr.
  - b) Boiler water treatment (monitoring and analysis of boiler water chemistry parameters) and quality management.

for at least one year in last seven (07) years ending last day of the month previous to the one in which bids are invited.

2. The Bidder should have executed operation/O&M work of DM plant or WCTP (Water Chemical Treatment Plant) during last seven (07) years, ending last day of the month previous to the one in which bids are invited of the following value:-
  - a) Single Order having a value not less than **Rs. 176.87 lakh.**  
Or
  - b) Two Orders having a value not less than **Rs. 110.54 lakh each.**  
Or
  - c) Three Orders having a value not less than **Rs. 88.43 lakh each.**

3. The average annual turnover of the Bidder in the preceding three (03) financial years as on the date of Techno-commercial bid opening **shall not be less than Rs. 110.54 lakhs.**

**Note:**

- ◆ The executed/completed portion of BOQ, even if the work has not been completed in totality (subject to furnishing of documentary proof of executed value of the work) can be considered against Cl- 2.
- ◆ Values as per Cl-2 shall be considered inclusive of Service Tax.
- ◆ While computing the annual turnover other income shall not be considered.
- ◆ In case where audited results for the last preceding financial year are not available, certification of financial statements from a practicing Chartered Accountant shall be considered acceptable.

## **NIT Conditions**

1. Bid documents will be issued to all the parties on their request (cost of tender document to be made by a **crossed demand draft / pay order / banker's cheque in favour of NSPCL payable at Bhilaj**) for issue of bid documents without prima-facie examination of their qualification status. However, issue of bid documents shall not mean that bidders are considered qualified. Tender document fee will not be refunded. Request for tender documents received after the last date as mentioned above due to delays postal/courier services shall not be entertained.
2. Complete set of bidding documents are also available on NTPC website **www.ntpctender.com** prospective bidders can download the same for submission of bids after tendering the cost of bidding documents directly on the website.
3. NSPCL reserves the right to reject any or all bids or cancel / withdraw the Invitation for bids without assigning any reason whatsoever and in such case no bidder / intending bidder shall have any claim arising out of such action.
4. Agencies are advised to visit the site to familiarize themselves with the nature of work and the site conditions.
5. Small-scale industries registered with NSIC/MSME shall be exempted for payment of EMD & Tender Fee.

6. If the last date of receiving application and date of bid opening coincide with a holiday, the date will be shifted to the next working day.
