QUALIFYING REQUIREMENT

1. Quality Management of Steam-Water & Operation of Water Treatment Plants, Expansion Power Plant, NSPCL-Bhilai.

- 1. The Bidder should have executed work of
 - a) Operation of water treatment plant for DM water production capacity at least 50 m3/hr.
 - b) Monitoring and analysis of water chemistry parameters and quality management of process plant / thermal power plant.

for at least one year in last 05 year ending last day of the month previous to the one in which bids are invited.

- 2. The Bidder should have executed operation work of DM plant and / or Water Treatment Plant during last seven years, ending last day of the month previous to the one in which bids are invited of the following value :
 - a) Single Order having a value not less than Rs. 102.75 lakh.

OR

b) Two Orders having a value not less than Rs. 64.22 lakh each.

OR

- c) Three Order having a value not less than Rs. 51.37 lakh each.
- 3. The bidder should have an average annual turnover during the last 3 years, ending 31st march of the previous financial year, not less than 64.22 lakhs.

Note:-The executed values at Sr. No.-2 shall be considered inclusive of service tax.

NIT Conditions

- Bid documents will be issued to all the parties on their request (cost of tender document to be made by a crossed demand draft / pay order / banker's cheque in favour of <u>NSPCL payable at Bhilai</u>) for issue of bid documents without prima-facie examination of their qualification status.
