#### **Instruction for e-bidding:**

- 1. The bidder must have Digital Signature Certificate (Class-III).
- 2. The bidders who already have valid SRM User ID:
  - a) Login the SRM Portal and click on RFx and Auction button.
  - b) Rfx will be available to view for all the bidders which are already having valid SRM User ID's.
  - c) Interested bidders have to register first against the Bid invitation by clicking on "Register" button placed into Rfx header segment.
  - d) Once Registration step & Tender fee submission is done by bidder and the tender fee received by the NSPCL and updated into the system then Bidder could be able to "Create Response" and submit the bids against the Bid invitation into the system.
- **3.** New Bidders who are not having SAP/ERP Vendor Code and / or SRM User ID:
  - a) In case a new bidder wants to participate for a particular Bid invitation in SRM portal, the bidder first of all has to submit the filled Registration Form & EFT Form along with required supporting documents e.g. as specified in forms, till **25.01.2025** to C&M department, NSPCL Bhilai in hard copy or scanned copy through e-mail at rnshukla@nspcl.co.in or ushakumai@nspcl.co.in.

- b) C&M department will initiate the process for vendor ID creation in SAP & send the bidder's SRM Credentials (User ID along with initial Password) to them.
- c) After creation of SRM Credentials the step 2 (above) shall be followed by the bidder.

1.0	Technical CRITERIA				
1.1	The bidder should have executed contract for similar work(s), in the preceding seven				
	(07) years; reckoned as on the date of technical bid opening with executed contract value(s) as				
	per below:				
	a) Single contract with executed value not less than Rs 64.51 Lakhs (inclusive of taxes)				
	b) Two contracts with executed value not less than Rs 40.32 Lakhs each (inclusive of taxes) OR				
	Three contracts with executed value not less than Rs 32.25 Lakhs each (inclusive of taxes)				
	NOTES for clause 1.0 above:				
	a. "Similar work" shall mean "Civil Construction / Civil Repair / Civil Maintenance work".				
	In case the bidder has executed the work of Horticulture along with Civil Construction /				
	Civil Repair / Civil Maintenance, then the entire executed value shall be considered.				
	However, in such case, the value of civil work should not be less than 50 percent of total				
	executed value or the values defined in clause 1.1 above.				
	b. The word "executed" at clause 1.1 means, bidder should have achieved the criteria specified in				
	above QR even if the total contract is not completed/ closed. The same shall be supported by				
	documentary evidence (copies of RA Bills, Relevant PO copy and Work Completion Certificate/				
	RA bill/ Final Deviation Statement ) issued by the Owner/ Employer.				
	C. The value of work completed in the preceding seven (7) years reckoned as on the date of				
	technical bid opening, even if it has been started earlier, will only be considered for				
	establishing the qualifying requirements.				
	d. For the purpose of arriving at the executed value of work specified at 1.1 above, amount				
	inclusive of taxes shall be considered.				
	e. In case the bidder has executed the work(s) as sub-vendor, then the bidder has to furnish documentary proof of approval from the principle owner for subletting the work(s).				
2.0	Financial Criteria:				
2.1	The average annual turnover of the Bidder in the preceding three (03) financial years,				
	reckoned as on the date of technical bid opening shall not be less than Rs 80.64 Lakhs				
	(Rupees Eighty lakhs Sixty Four thousand only inclusive of taxes).				
	Notes:				
	a. In case where audited results for the last financial year as on the first scheduled date of				
	Technical bid opening are not available, the financial results certified by a practicing				
	Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the Certificate from a practicing Chartered Account certifying its financial parameters, the				
	audited results of three consecutive financial years preceding the last financial year shall be				
	considered for evaluating the financial parameters. Further, a certificate would be required				
	from the CEO/CFO/ Proprietor/Partners as per the format enclosed in the bidding				
	documents stating the financial result of the company are under audit as on the date of				

Technical bid opening and the certificate from the practicing Chartered Accountant certifying the financial parameters is not available.

- b. Other income shall not be considered for arriving at annual turnover.
- C. The bidder should submit documentary proof for establishing the QR requirements at 1.0 and 2.0 above.

# **NIT Conditions**

- 1. Bid documents will be issued to all the parties on their request (cost of tender document to be made by a crossed demand draft / pay order / banker's cheque in favour of NTPC SAIL POWER COMPANY LIMITED payable at Bhilai) for issue of bid documents without prima-facie examination of their qualification status. However, issue of bid documents shall not mean that bidders are considered qualified. Tender document fee will not be refunded. Request for tender documents received after the last date as mentioned above due to delays postal/courier services shall not be entertained.
- 2. NSPCL reserves the right to reject any or all bids or cancel / withdraw the Invitation for bids without assigning any reason whatsoever and in such case no bidder / intending bidder shall have any claim arising out of such action.
- 3. Agencies are advised to visit the site to familiarize themselves with the nature of work and the site conditions.
- 4. If the last date of receiving application and date of bid opening coincide with a holiday, the date will be shifted to the next working day.
- 5. BEING WORKS CONTRACT, MSE BENEFIT IS NOT APPLICABLE.
- 6) Any Certificate(s) / Financial Statement(s) / Audited Balance Sheet and P&L Account (wherever applicable) undertaken/ signed by a Member of Institute of Chartered Accountant of India (ICAI), which Bidders submit in support of compliance to Qualifying Requirements (QR), will carry Unique Document Identification Number (UDIN) generated in line with the Gazette Notification of Council of Institute of Chartered Accountant of India (ICAI).
- 7)Notwithstanding anything stated above, the Employer reserves the right to assess the credentials/capabilities/capacity of the Bidder/ his collaborators / associates/ subsidiaries / group companies to perform the contract, should the circumstances warrant such assessment in the overall interest of the Employer. The physical or any mode of assessment/verifications by Employer shall include but not be limited to the assessment/verifications of office/ facilities/ banker's/ submitted reference works in lieu of credentials. A negative determination of such assessment of credentials/capacity/capabilities may result in rejection of the bid.
- 8) The reference works whose details have been declared in their bid shall only be considered to ascertain the bidder's compliance to the specified qualifying Requirement (QR). The Employer at its discretion may seek any clarification and/or documentary evidence only for the reference works as mentioned above. However, no change or substitution of the reference works by new/additional plant for conforming to the specified qualifying Requirement shall be sought, offered or permitted".
- 9) "Bidders are required to furnish the details of the past experience like authentic Work Orders/Purchase Orders/Letter of Awards/Contract Agreements, client certificates, completion certificate, etc. in support of meeting the Qualifying Requirements based on which selection is to be made as per format. However, if any of the Work Orders/Purchase Orders/Letter of Awards/Contract Agreements pertains to the work executed by Bidder for NSPCL in the past, then in respect of such Work Orders/Purchase Orders/Letter of Awards/Contract Agreements, Bidder shall not be required to enclose Client Certificate along with its Bid."

All the bidders, who are required to submit the details of the past experiences, shall submit all the documents, in support of Technical Qualification Requirements (such as copy of Purchase Orders/ Work Orders/ Contract Agreements/ Client Certificates etc.), duly certified and verified for authenticity from Independent Statutory Auditor of their Company or specified Third-Party Inspection Agency (TPIA).

Further, wherever information can be drawn from books of accounts, records and other relevant documents, Bidders can also submit a certificate issued by their Independent Statutory Auditor certifying the data required for meeting the Technical Qualification Requirements.

Such bidder shall be required to submit duly certified and verified documents from their Statutory Auditors or specified TPIA in support of meeting Technical QR along with a certificate regarding verification of authenticity of documents as per the format placed at Annexure-II Undertaking from Statutory Auditor) and/ or Annexure-III Undertaking from TPIA). All the documents submitted by the bidder in support of meeting Technical QR shall be digitally signed by the Statutory Auditor and/ or specified TPIA.

(iii) The Bidder shall be responsible to get their documents/ credentials in support of Qualifying Requirements verified & certified by their Statutory Auditor(s) and/ or specified TPIAs. All the costs pertaining to third party verification and certification (including those by statutory auditors) shall be borne by the Bidder. Employer shall have no liability (financial or otherwise) towards the same and shall not be liable for any claim/ dispute between the bidder and TPIA and/ or Statutory Auditor.

- 10) 'Class-I local suppliers' only are eligible to participate in this tender, as defined in the bidding documents/ Public Procurement (Preference to Make in India), Order 2017 and its subsequent amendments/ revisions issued by DPIIT. The bidders may apprise themselves of the relevant provisions of bidding documents in this regard before submission of their bids.
- 11) Any 'Bidder from a country which shares a land border with India', as specified in the Bidding Documents, will be eligible to bid in this tender only if bidder is registered with the Competent Authority as mentioned in the Bidding Documents.

However, the said requirement of registration will not apply to bidders from those countries (even if sharing a land border with India) to which the Government of India has extended lines of credit or in which the Government of India is engaged in development projects.
