<b>1.1</b>	<p>The Bidder should have executed <b>Similar Work(s)</b> during the preceding 7 (seven) years reckoned as on the date of technical bid opening having:</p> <p>a) Executed value not less than <b>Rs. 79.69 lakhs</b> in a Single Order. OR b) Executed value not less than <b>Rs. 49.81 lakhs</b> in two Orders each. OR c) Executed value not less than <b>Rs. 39.84 lakhs</b> in three Orders each.</p>
<b>2.0</b>	<b>Financial Requirement:</b>
<b>2.1</b>	<p>The average annual turnover of the Bidder, in the preceding three (3) financial years as on the date of Technical bid opening should not be less than <b>Rs. 99.62 Lakhs</b> (Indian Rupees Ninety-Nine Lakhs Sixty Two Thousand only).</p>

Further, a Certificate would be required from the CEO/CFO/Proprietor/Partner as per the format enclosed in the bidding documents stating that the Financial results of the Company are under audit as on the date of Techno commercial bid opening and the Certificate from the practicing Chartered Accountant certifying the financial parameters is not available</p> <p>v) <b>Other income</b> shall not be considered for arriving at annual turnover.</p>

3. Agencies are advised to visit the site to familiarize themselves with the nature of work and the site conditions.
4. If the last date of receiving application and date of bid opening coincide with a holiday, the date will be shifted to the next working day.
5. Micro and Small Enterprises (MSEs) registered with Udyam as specified by Ministry of Micro, Small and Medium Enterprises as per MSMED Act 2006, for goods produced and services rendered, shall be issued the bid documents free of cost and shall be exempted from paying Earnest Money Deposit & shall be issued the bidding documents free of cost and shall be exempted from payment of Tender Fee.
