 - c) Interested bidders have to register first against the Bid invitation by clicking on "Register" button placed into Rfx header segment.
 - d) Once Registration step & Tender fee submission is done by bidder and the tender fee received by the NSPCL and updated into the system then Bidder could be able to "Create Response" and submit the bids against the Bid invitation into the system.

2.1	The average annual turnover of the Bidder, in the preceding three (3) financial years as on the date of Technical bid opening should not be less than Rs. 53.63 Lakhs .				
<u>Note</u>	 i) Values as per clause 1.1 and 2.1 shall be considered inclusive of taxes & duties ii) The word "Executed" means the bidder should have achieved the criterion specified in Qualifying Requirements, even if the total contract is not completed/closed. A work executed in the preceding seven (7) years reckoned as on the date of technical bid opening, even if it has been started earlier, will also be considered for meeting the requirement against clause 1.1 above.
