**Instruction for e-bidding:**

1. The bidder must have Digital Signature Certificate (Class-III).

2. The bidders who already have valid SRM User ID:

a) Login the SRM Portal and click on RFx and Auction button.

b) Rfx will be available to view for all the bidders which are already having valid SRM User ID's.

c) Interested bidders have to register first against the Bid invitation by clicking on "Register" button placed into Rfx header segment.

d) Tender document fee should be submitted on line/offline (Demand Draft / Pay Order / Banker's Cheque only except exemption document and EMD also may be submitted online/offline.

e) Once Registration step & Tender fee submission is done by bidder and the tender fee received by the NSPCL and updated into the system then Bidder could be able to "Create Response" and submit the bids against the Bid invitation into the system.

3. New Bidders which are not having SAP/ERP Vendor Code and or SRM User ID:

a) In case a new bidder wants to participate for a particular Bid invitation in SRM portal, the bidder first of all has to submit the filled Registration Form & NEFT Form along with required supporting documents e.g. as specified in forms, till **12/02/2022** to C&M department, NSPCL Bhilai in hard copy or scanned copy through e-mail at: rashmikumari@nspcl.co.in

b) C&M department will initiate the process for vendor ID creation in SAP & send the bidders SRM Credentials (User ID along with initial Password)

c) After creation of SRM Credentials the step 2 (above) shall be followed by the bidder.

## QUALIFYING REQUIREMENT

**Name of Work: "Monitoring and management of water quality, Operation of WCTP(DM Plant & PT Plant) and other services at Power Plant-2, NSPCL-Bhilai".**

### **1.0 Technical Requirement:**

- 1.1 The bidder should have **executed similar work(s)** successfully during last 07 years reckoned as on the date of technical bid ending in any of the following manner:
- a) Executed value not less than **Rs. 82.07 lakh** in a Single Order.
  - b) Executed value not less than **Rs. 51.29 lakh in two orders each.**
  - c) Executed value not less than **Rs. 41.03 lakh in three orders each.**

### **2.0 Financial Requirement:**

- 2.1 The average annual turnover of the Bidder in the preceding three (03) financial years as on the date of Technical bid opening should not be less than **Rs.102.58 lakh.**

#### **Notes:**

- I. The phrase "Similar Works" means: "Operation of water treatment plant having capacity of at least 50 m<sup>3</sup>/hr DM water production and Monitoring and analysis of boiler water chemistry parameters and quality management of water and steam cycle chemistry of a thermal power plant / process plant".
- II The word "Executed" means the bidder should have achieved the criterion specified in Qualifying Requirement, even if the total contract is not completed/closed. A work completed) in the preceding seven(7) years reckoned as on the date of technical bid opening, even if it has been started earlier, will also be considered for meeting the qualifying requirement. In all cases the full value of the executed value of the work in the form of copies of RA Bills, Relevant PO copy and client's completion certificate/RA bill/Final Deviation Statement etc. in support of meeting Qualifying Requirement.
- III Values as per Clause 1.1 and 2.1 shall be considered inclusive of taxes & duties.
- IV Other income shall not be considered for arriving at annual turnover.
- V In case where audited results for the last financial year as on the date of Technical bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the Certificate from a practicing Chartered Account certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a certificate would be required from the CEO/CFO/ Owner/Partners as per the format enclosed in the bidding documents stating the financial result of the company are under audit as on the date of Technical bid opening and the certificate from the practicing Chartered Accountant certifying the financial parameters is not available.

## **NIT Conditions**

1. Bid documents will be issued to all the parties on their request (cost of tender document to be made by **a crossed demand draft / pay order / banker's cheque in favour of NTPC SAIL POWER COMPANY LIMITED payable at Bhilai**) for issue of bid documents without prima-facie examination of their qualification status. However, issue of bid documents shall not mean that bidders are considered qualified. Tender document fee will not be refunded. Request for tender documents received after the last date as mentioned above due to delays postal/courier services shall not be entertained.
2. NSPCL reserves the right to reject any or all bids or cancel / withdraw the Invitation for bids without assigning any reason whatsoever and in such case no bidder / intending bidder shall have any claim arising out of such action.
3. Agencies are advised to visit the site to familiarize themselves with the nature of work and the site conditions.
4. If the last date of receiving application and date of bid opening coincide with a holiday, the date will be shifted to the next working day.
5. Micro and Small Enterprises (MSEs) registered with Udyam as specified by Ministry of Micro, Small and Medium Enterprises as per MSMED Act 2006, for goods produced and services rendered, shall be issued the bid documents free of cost and shall be exempted from paying Earnest Money Deposit & shall be issued the bidding documents free of cost and shall be exempted from payment of Tender Fee.
