  - b) Rfx will be available to view for all the bidders which are already having valid SRM User ID's.
  - c) Interested bidders have to register first against the Bid invitation by clicking on "Register" button placed into Rfx header segment.
  - d) Once Registration step & Tender fee submission is done by bidder and the tender fee received by the NSPCL and updated into the system then Bidder could be able to "Create Response" and submit the bids against the Bid invitation into the system.
3. New Bidders who are not having SAP/ERP Vendor Code and / or SRM User ID:

	<p>a. “Similar work” shall mean <b>“The bidder should have executed the work of Construction/ Repair of road(s) consisting of Pre-mix bituminous carpet and/or WBM and/or WMM &amp; Bituminous Road”</b>.</p> <p>b. The word “executed” at clause 1.1 means, bidder should have achieved the criteria specified in above QR even if the total contract is not completed/ closed. The same shall be supported by documentary evidence (copies of RA Bills, Relevant PO copy and Work Completion Certificate/ RA bill/ Final Deviation Statement ) issued by the Owner/ Employer.</p> <p>c. The value of work completed in the preceding seven (7) years reckoned as on the date of technical bid opening, even if it has been started earlier, will only be considered for establishing the qualifying requirements.</p> <p>d. <b>2.1</b>	<p>The average annual turnover of the Bidder in the preceding three (03) financial years, reckoned as on the date of technical bid opening shall not be less than <b>₹ 82.99 Lakhs</b> (Rupees Eighty-Two lakhs Ninety-Nine thousand only inclusive of taxes).</p>
	<b>Notes:</b>
	<p>a. In case where audited results for the last financial year as on the first scheduled date of Technical bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the Certificate from a practicing Chartered Account certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a certificate would be required from the CEO/CFO/ Proprietor/Partners as per the format enclosed in the bidding documents stating the financial result of the company are under audit as on the date of Technical bid opening and the certificate from the practicing Chartered Accountant certifying the financial parameters is not available.</p> <p>b. Other income shall not be considered for arriving at annual turnover.</p> <p>c. The bidder should submit documentary proof for establishing the QR requirements at 1.0 and 2.0 above.</p>
