**QUALIFYING REQUIREMENTS**

The bidders who wish to participate in the bidding shall satisfactorily establish that they fulfil the following Qualifying Requirements.

- 1.0 The average annual turnover of the bidder, in the preceding three (03) financial years as on date of bid opening shall not be less than Rs. 494.928 Lakhs.
- 2.0 Experience of having successfully completing the similar works/Purchase within preceding seven (07) years reckoned as on the date of Bid Opening, should be either of the following.
  - (A) Three similar completed works/purchase each costing not less than the amount equal to **Rs. 49.49** Lakhs.

OR

  - (B) Two similar completed works/purchase each costing not less than the amount equal to Rs. **61.86** Lakhs.

OR

  - (C) One similar completed works/purchase costing not less than the amount equal to Rs. **98.98** Lakhs.

**NOTE:- "Similar Work"** means:- Supply of ERW Pipes (MS) of minimum size 323.9 X 9.5 mm.

**TERMS AND CONDITIONS**

- 1 Bid documents will be issued to all the parties on their request for issue of bid documents without prima-facie examination of their qualification status. However, issue of bid documents shall not mean that bidders are considered qualified. Such requests must be submitted on or before **19.07.2014** on any working day between 9 AM to 5.30 PM with cost of tender documents of **Rs. 2,250.00** in the form of crossed demand draft from any Nationalized Bank in favour of NSPCL-Bhilai, payable at Bhilai. **Cash Payment/Money Order will not be accepted.** Tender document fee will not be refunded. **Request for tender documents received after the sale close date as mentioned above due to delays postal/courier services shall not be entertained.**

5. NSPCL reserves the right to reject any or all bids or cancel / withdraw the Invitation for bids without assigning any reason whatsoever and in such case no bidder / intending bidder shall have any claim arising out of such action.
6. **ANY BIDS NOT ACCOMPANIED BY AN ACCEPTABLE BID SECURITY IN A SEPARATE SEALED ENVELOPE SHALL BE REJECTED BY THE NSPCL AS BEING NON-RESPONSIVE AND RETURNED TO THE BIDDERS WITHOUT BEING OPENED.**
7. Indenting parties are advised to visit the site to familiarize themselves with the nature of work and the site conditions.
8. Small-scale industries registered with NSIC shall be exempted for payment of EMD provided the quoted value is within the monetary limit for the said unit set by NSIC  
*(Subject to submission of copy of registration giving details, such as validity, monetary limit, etc.)*
9. If the last date of receiving application and date of bid opening coincide with a holiday, the date will be shifted to the next working day.
