1. The bidder must have Digital Signature Certificate (Class-III).

**2.** The bidders who already have valid SRM User ID:

a) Login the SRM Portal and click on RFx and Auction button.

b) Rfx will be available to view for all the bidders which are already having valid SRM User ID's.

c) Interested bidders have to register first against the Bid invitation by clicking on "Register" button placed into Rfx header segment.

d) Tender document fee should be submitted on line/offline (Demand Draft / Pay Order / Banker's Cheque only except exemption document and EMD also may be submitted online/offline.

e) Once Registration step & Tender fee submission is done by bidder and the tender fee received by the NSPCL and updated into the system then Bidder could be able to "Create Response" and submit the bids against the Bid invitation into the system.

3. New Bidders which are not having SAP/ERP Vendor Code and or SRM User ID:

a) In case a new bidder wants to participate for a particular Bid invitation in SRM portal, the bidder first of all has to submit the filled Registration Form & NEFT Form along with required supporting documents e.g. as specified in forms, till **10.02.23** to C&M department, NSPCL Bhilai in hard copy or scanned copy through e-mail at: rashmikumari@nspcl.co.in

b) C&M department will initiate the process for vendor ID creation in SAP & send the bidders SRM Credentials (User ID along with initial Password)

c) After creation of SRM Credentials the step 2 (above) shall be followed by the bidder.

# **QUALIFYING REQUIREMENT**

# Name of Work: "Transportation of coal from Gevra OCP to nearby railway siding/Goods Shed/Private Siding & loading into IR wagons for onward transportation to NSPCL Bhilai".

1	Technical Criteria			
1.1	The bidder should have executed the work of "Loading/Unloading" & "transportation by road" of Coal/Overburden/Soil/Minerals/shale during the preceding seven years reckoned from the date of techno commercial bid opening meeting the following criteria:			
	The bidder should have successfully executed the work for minimum total quantity of 80,000 MT in a continuous period of 4 months in not more than two contracts.			
Note	The word "Executed" mentioned in clause 1.1 means that the Bidder should have achieved the criteria specified above, even if the total contact is started earlier and/or is not completed/closed.			
2	Financial Criteria			
2.1	The average annual turnover of the Bidder in the preceding three (03) financial years as on the date of techno commercial bid opening should not be less than <b>Rs 750 Lakhs</b> (Rs. Seven Crores and Fifty Lakhs Only)			
2.2	Net worth requirement to be specified as not being less than 100% of the Bidder's paid up share capital as on the last day of the preceding financial year. In case the Bidder meets the requirement of Net worth based on the strength of its Subsidiary(ies) and/or Holding Company and/or Subsidiaries of the Holding Companies wherever applicable, the Net worth of the Bidders and its Subsidiary(ies) and/or Holding Company, and/or Subsidiary(ies) of the Holding Company, in combined manner should not be less than100% of their total paid up share capital. However, individually, their Net worth should not be less than 75% of respective paid up share capitals. For Consortium/Joint Ventures, wherever applicable, the Net worth of all consortium/Joint Venture members in combined manner should not be less than 75% of their respective paid up share capital. However individually their Net worth should not be less than 75% of their spective paid up share capital. However individually their Net worth should not be less than 75% of their spective paid up share capital. 	Net worth in combined manner shall be calculated as follows: <b>Net worth (combined)=(X1+X2+X3) / (Y1+Y2+Y3) X 100</b> Where X1, X2 X3 are individual net worth which should not be less than 75% of the respective paid up share capitals and Y1, Y2, Y3 are individual paid up share capitals.			
2.3	In case, a bidder does not satisfy the financial criteria, stipulated at clause 2.1 above on its own, the holding company would be required to meet the stipulated turnover requirements at clause 2.1 above, provided that the net worth of such holding company as on the last day of preceding financial year is at least equal to or more than the paid-up share capital of the holding company. In such an event, the bidder would be required to furnish along with its bid, a Letter of Undertaking from its holding company, supported by Board Resolution, as per the format enclosed in the bid documents, pledging unconditional and irrevocable financial support for the execution of the contract by the bidder in case of award.			
2.4	In case the bidder is not able to furnish its audited financial statements on standalone entity basis, the un-audited unconsolidated financial statements of the bidder can be considered acceptable provided the bidder furnishes the following further documents on substantiation of its qualification			
	<ol> <li>Copies of the un-audited unconsolidated financial statements of the Bidder along with copies of the audited consolidated financial</li> </ol>			

statements of the Holding Company.
2. A Certificate from the CEO/CFO of the Holding Company, as per the format enclosed in the bid documents, stating that the un-audited unconsolidated financial statements form part of the Consolidated Annual report of the company.
In case where audited results for the last financial year as on the date of techno commercial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the certificate from practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a Certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that the Financial results of the Company are under audit as on the date of Techno commercial bid opening and the Certificate from the practicing Chartered Accountant certifying the financial parameters is not available.
<ol> <li>Net worth means the sum total of the paid up share capital and free reserves. Free reserve means all reserves credited out of the profits and share premium account but does not include reserves credited out of the revaluation of the assets, write back of depreciation provision and amalgamation. Further any debit balance of Profit and Loss account and miscellaneous expenses to the extent not adjusted or written off, if any, shall be reduced from reserves and surplus.</li> <li>Other income shall not be considered for computing annual turnover.</li> <li>"Holding Company" and "Subsidiary Company" shall have the meaning ascribed to them as per Companies Act of India, in vogue.</li> <li>The figures indicated in 2.1 are inclusive of Taxes and Duties.</li> </ol>

# **NIT Conditions**

- 1.
